Treasurer's Update

- Voted to designate our Treasurer, Andrew Riester, as master administrator for QuickBooks. Linda Manning will provide documentation to verify the vote to QuickBooks.
- Profit and Loss statement reviewed, as well as Wreath, Poinsettia, & Coffee Sale financials. Mari, Heidi, and Andrew will continue to analyze routes, profits, etc. for WP&C and for letter writing campaign. Projected net profit is \$8,665.84.
- Crew Boosters credit card is still being pursued; there has been a disconnect between school front office and Crew Boosters.
- Winter conditioning coaches (Rob and Shannon) will be paid, based on the daily rate, per Coach Mike's attendance record.
- A gift acknowledgement will be sent to Ms. Venzke for her donation of an erg to the team.
- Purchase of an 8 confirmed.
 - Crew Boosters made a verbal contract for the purchase of an 8 to replace the 1992
 Mayflower. Of the \$17,000 (approx.) price, \$7,000 will be drawn from existing capital fund.
 Another \$2,500 will be transferred from this year's WP&C proceeds. There remains \$7,500 to raise.
 - A 25% deposit is due now-ish; the remainder will be due upon receipt of the boat. The
 deposit will be paid when an invoice is presented. Those funds are available now.
 - o For the remainder, we will need to raise that money. Meanwhile, current and recent past members will be asked to float no-interest loans to tide us over financially.
 - o It was recommended an e-mail appeal for donations before the end of the current tax year be sent to the current and alumni members and friends.

Wreath distribution and delivery – Tabled until next meeting.

Fundraising

- 50th Anniversary Gala was discussed.
 - Linda, Catherine, Chip, and Andrew will meet to brainstorm. Linda will contact Nancy Witkowski to ask that she join the brainstorming/planning group.
 - Linda has been in touch with Daniel James Brown's agent (author of <u>The Boys in the Boat</u>).
 He is one idea for a speaker for the gala.
 - Three elements of the event:
 - Reach out to historical/alumni rowers and friends to honor and celebrate them.

- Recruit current rowing families, both from Stuart HS and other schools to promote rowing today.
- Tie in the celebration of 50 years of Raider rowing with how to move forward with honoring the Miss Fairfax and its history.
- Heidi Gioseffi will reach out to her contacts to develop a design for the 50th anniversary, to be used for shirts and promotional materials for the event. Deadline for the design is Jan. 15.
- Yard Sale Freya has offered furniture from her parent's home as a donation to the team. We can then sell the furniture and keep the proceeds. Suggested considering selling on Craig's List as an alternative to a traditional yard sale.
- Chipotle net was \$350. This was a "freebie" due to cancelled event in 2014.
- Mari will reach out to other parents to take leadership with restaurant fundraisers.

Spirit wear/Uniforms

- Sandy Fitzgerald has offered to take over leadership with spirit wear.
- Chip will continue to manage the boathouse jacket order.
- Linda will place uniform order.
- After the winter break, team captains will measure students needing to order for the first time.
 Uniform pieces will be ordered in early February.

Coach's Report

- Average student attendance at winter conditioning is 26, up from average of 20 students last year.
- Coach Mike is looking to borrow 6 more ergs from Prince William Rowing Club (PWRC).
- The refurbished sweep oars ordered from Croker have not been delivered yet.
- A stroke coach was donated to the team by a friend of Coach Mike's. It is a \$200 piece of equipment. A thank-you will be sent.
- Work is on-going to repair rentals returned by Resilient.
- Resilient still owes payment #2.
- Coaching staff:
 - o Evan is no longer coaching, since he has left to attend Shenandoah University.
 - Sarah is likely not available, due to her new coursework schedule.
 - Sergio may be available.
 - There are two PWRC adult rowers who may be resources to fill the gaps.
- The regatta schedule has been finalized.

Other: Currently, there are 36 registered rowers, and another 11 rowers with intent but incomplete registration packets. Novice girls is where the team may be short.
