TREASURER'S REPORT

- As of today, the Boosters have \$46,000 in our account.
- Extension for tax return has been filed.
- Upcoming major expenses: \$560 for oars (from Croker Oars); approximately \$960 for engine and head gasket repairs; shoe bill; additional uniforms; website updates bill; and second half of the new boat cost.
- Anne will prepare a list of expenses from 8/1/17 to present and calculate total revenues since 8/1/17. Linley M. will help Anne with QuickBooks.

VASRA REQUIREMENTS

- There is no May meeting scheduled.
- All volunteer positions have been filled.
- Mari will contact rowers and coaches whose waivers will expire during the season.

BOATS & MAINTENANCE

- Linda will call Steve Welch to fix trailer lights before Mathews trip on May 3.

SPRING SCHEDULE

- Moving practice from April 27 to April 25 (a Wednesday) due to Prom.
- Mathews Regatta: Derig boats and load trailer on Thursday, May 3. Travel and rig boats on Friday, May 4. Rowers arrive on Saturday, May 5. Need sign-ups for food contributions. Coach Mike will email additional info. Need \$195 check for regatta entry fee.
- Entries for VSRC Regatta need to be made by April 30/May 1.
- Stotesbury Regatta: Participating rowers will be notified by the first week of May. Parents will drive rowers (no bus). Linda has reserved hotel rooms; Vivian H. will work with Linda to

coordinate. Boosters have no funds reserved for this regatta so rowers will need to pay for hotel and some food expenses. Still looking for parent chaperones and drivers.

- End-of-year awards ceremony is on June 3. Will invite Penny Gros, Brian Garvey and Deb O'Rourke.

FUNDRAISING

- Earth Day event setup starts at 11:30. Linda will contact captains to make sure rowers come and stay till the end of the day. Linda and Mari will shop for the food.
- Car Wash dates need to be given to Andrew Reister so he can reserve with First Christian Church. Schedule for late May/early June, August and September. Need a parent to coordinate – set up and put away hoses and buckets, bring supplies, supervise. Linda will put out the call for volunteer parents. Team usually makes approximately \$750 for the day.
- Team will participate as a food concession (desserts) in the Battle of the Bands in September 2018 at Beach 5. This Stuart Educational Fund event is also a good opportunity for recruiting. Team netted approximately \$750 last September.

ALUMNI EVENT

- We need to start advertising this event that honors Henley 8 men's team on the 50th anniversary of their Henley championship.
- Must involve alumni groups young and old in hopes that they will support the team even more.
- Heidi will create a Save-the-Date flyer and 5-question survey about what the event should include, to be sent out electronically in the next week.
- Consider inviting press to the event and trying to get sponsors and donations for the weekend event.
- Linda and Vivian will work together on event planning tasks.

RECRUITING

- Team will do Glasgow MS ERG Days again in all 8th grade P.E. classes sometime in June.
- Coach Mike will hold Learn-to-Row camp this summer. Heidi will update the flyers.
- Increase efforts to make the sport of rowing more visible at school and attend more school events with banners that say "JOIN CREW."
- Linda will forward to Brian Garvey blurbs about regatta results for inclusion in the KIT messages.

NAME CHANGE

- Many groups/teams at Stuart have already started using the new logo. Crew needs to be ready to switch over when the school officially becomes Justice HS.
- Oars will all need to be redone this summer with the new design. Minimal changes preferred.
